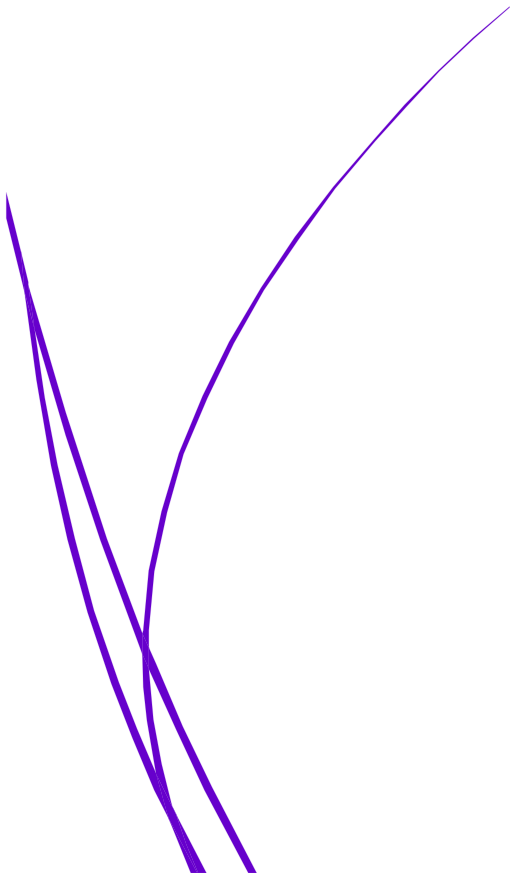

**Statistical Analysis:

Introduction

This paper presents statistical data on incidents of domestic violence, which were reported to the Royal Grenada Police Force (RGPF) between 2012 and 2016, in which the use of drugs was reported, detected, or identified by the RGPF, during its investigation of the said incidents. It also presents data on domestic violence and homicides, and children who were victims of domestic violence.

This paper does not identify determinant factors which led to incidents of domestic violence, nor does it determine the roles of the persons involved. No recommendations are presented to address these incidents.

Definitions

Alleged offender means to any person at the scene of an incident of domestic violence, whom a Police Officer reasonably suspects of having committed an act of domestic violence.

Child¹ means a person under the age of eighteen years who–

- (a) normally resides with the applicant, whether or not the child is a child of the applicant and the respondent, or either of them;
- (b) is an adopted child, a stepchild, a child who is treated as a child of the family;
- (c) is related by consanguinity or affinity, to either the applicant or the respondent;
- (d) (d) is in the care and protection of the applicant or the respondent;
- (e) (e) is a person of whom either the applicant or the respondent is a guardian; or
- (f) is, or was, a member of a shared household; and
- (g) (g) is not a person who is, or was married;

Domestic violence² means any controlling or abusive behaviour that harms the health, safety or well-being of a person or any child, and includes but is not limited to the following–

- (a) physical abuse or threats of physical abuse;

- (b) sexual abuse or threats of sexual abuse;
- (c) emotional, verbal or psychological abuse;
- (d) economic abuse;
- (e) intimidation;
- (f) harassment;
- (g) stalking;
- (h) damage to or destruction of property; or
- (i) entry into the applicant's residence without consent, where the parties do not share the same residence.

Victim³ means any person who alleges to have been subjected to an act of domestic violence

Description of Current Situation

An Eye Witness Account of Domestic Violence

‘She stood there all alone, well, not quite alone. Her male companion was there, but not to love and protect her. She stood still, unflinching, her arms hung listlessly at her side, as he rained physical blows on her. It seemed that all sound had vanished from her; she did not sob, she did not plead, she did not ask any questions. Sounds failed to emanate from her. She stood there powerless, rooted by fear, as her lover continued to beat her into submission. He had accomplished his mission because she had already submitted to the merciless physical violence he vented on her.

Momentarily, I was halted by fear, and trepidation. A sigh, or gasp failed me. I also became soundless. It was the first time I had witnessed such a scene. I foolishly thought that he was just beating her. I did not know that it was domestic violence. I also was powerless; I was unable to intervene and put an end to this nightmare. There were no mobile phones, no social media I could use to send out a distress signal. It was 1988, and 1:00 a.m. As I shook off the fear, I quickened my footsteps, to escape this hellish situation. I escaped the scene, but she was trapped and remained there

It’s now twenty-nine years later. I don’t know whether she survived the ordeal; I don’t know if she reported the matter to anyone; I don’t know whether he had an encounter with the justice system for the harm he inflicted on his lover.

Sadly, I don’t know whether that was the last occasion he engaged in such despicable acts, or how many more nights she stood alone, unflinching and soundless, subjected to the brutal force of her lover. It took me twenty-nine years to discover that what I witnessed was domestic violence.’

Literature Review

Domestic violence (DV) is a serious problem and in recent years a large amount of emphasis has been put on prevention, protection and justice (Cho 2011). The National Society for the Prevention of Cruelty to Children (NSPCC 2012) in Britain has identified that African-Caribbean women live with high levels of abuse over long periods, with the majority experiencing daily abuse before separation. Reports indicate that several of incidents of DV occurs daily in homes. The evidence suggests that the sanctuary of the home may also be a place of peril, incubating horrendous acts of violence (West Indian Medical Journal, 2010).

Reports emanating from the Domestic Violence Unit of the Ministry of Social Development and Housing, the Grenada National Organization of Women (GNOW and the Legal Aid and Counselling Clinic, indicate that domestic violence, and in particular domestic violence against women is of grave concern. The view has been expressed that domestic violence is prevalent and under reported.

Substance use is a factor in many cases of domestic violence, either for the abusive partner, the person being abused or both (Soper, 2014). While substance use does not cause domestic violence, it is generally agreed that there is a correlation between the two issues. Studies have shown that there is frequent high prevalence of alcohol and other drug use, prior to or during incidents of domestic violence. Regular alcohol use is one of the leading factors for domestic violence and also intimate partner violence (IPV). Studies show that more than twenty percent of male perpetrators report using alcohol and/or illicit drugs prior to the most recent and severe acts of violence. Substance abuse has been found to co-occur in 40-60% of IPV incidents across various studies (Soper, 2014).

The Jamaica Observer Newspaper in Jamaica (May 2017), reported that substance abuse is a high-risk factor for violence against women and girls. Substance use can also increase the risk of persons becoming both perpetrator and victims of domestic violence. Further, the victims of domestic violence may even begin to consume drugs, as a means of coping with the violence. International studies show that eighty-seven percent of domestic violence program directors agree with the statement that the risk of intimate partner violence increases when both partners abuse drugs or alcohol.

Data exists in Grenada to support incidents of domestic violence associated with substance use, particularly alcohol. The Royal Grenada Police Force and other local Organizations have reported such incidents. Some of this data is presented in this paper.

Legislative Framework

Domestic violence is criminalized in Grenada, through various pieces of legislation. These include: Domestic Violence Act (2010), Criminal Code Cap 1 (1990 Continuous Revised Edition, and The Criminal Code Amendment Act (2012).

The Domestic Violence Act, which came into force on May 16, 2011, has provided the mechanism for an improved response to the issue of domestic violence and related concerns. It

also protects anyone who has an intimate relationship with someone of the opposite sex. This includes women and men who: are currently married to each other; are living together as partners, though not legally married; are the parents of a child, and are family members related by blood, marriage or adoption;

Treaties, Conventions, Agreements

Grenada is signatory to several Conventions regarding domestic violence and related matters. These include: Convention on the Elimination of all Forms of Discrimination Against Women (CEDAW), (1990), The 1995 Beijing Declaration and Platform for Action, the Inter American Convention on the Prevention, Punishment and Eradication of Violence (Belem do Para).

National Response

Several NGO's respond to the issue of domestic violence and have initiated intervention measures to address the subject. These organizations include: Grenada National Organizations of Women (GNOW), Legal Aid and Counselling Clinic LACC), Grenada National Coalition on the Rights of the Child (GNCRC), Inter-Agency Group of Development Organizations (IAGDO), and the Grenada Human Rights Organization (GHRO). They have partnered with regional and international organizations including the United Nations, to conduct such programmes.

The Government of Grenada's response is led primarily by the Domestic Violence Unit, of the Ministry of Social Development and Housing. The Domestic Violence Unit was established in 2003 to address the increasing incidence of domestic violence occurring in the State. According to the Government of Grenada's website (www.gov.gd), the main goal of the Domestic Violence Unit is to provide protection and support structures to effectively address issues of domestic violence within the State. Its objectives include:

- i. To adequately address various issues of domestic violence and other forms of abuse on a national level;
- ii. To heighten public awareness of domestic violence, and
- iii. To provide educational programmes nation-wide on the root causes of domestic violence, its effects on the individual and families with an emphasis on prevention

The Domestic Violence Unit was renamed in 2013 to the Gender-Based Violence (GBV) Unit; and the mandate was expanded to address other forms of GBV, in particular sexual violence.

The Royal Grenada Police Force (RGPF), which is responsible for enforcing laws in Grenada, and the Ministry of Education, Human Resource Development and The Environment, also play an active role in conducting education programmes on the subject of domestic violence.

Statistics on Domestic Violence, 2012 to 2016

Tables (1 & 2) show the number of alleged offenders arrested and charged by the Royal Grenada Police Force for offences in relation to domestic violence, and victims of domestic violence, between 2012 and 2016.

The year 2016 recorded the highest number of alleged offenders (males and females) who were arrested and charged for offences associated with domestic violence; 870 alleged offenders were arrested and charged by the Royal Grenada Police Force. (Table 1)

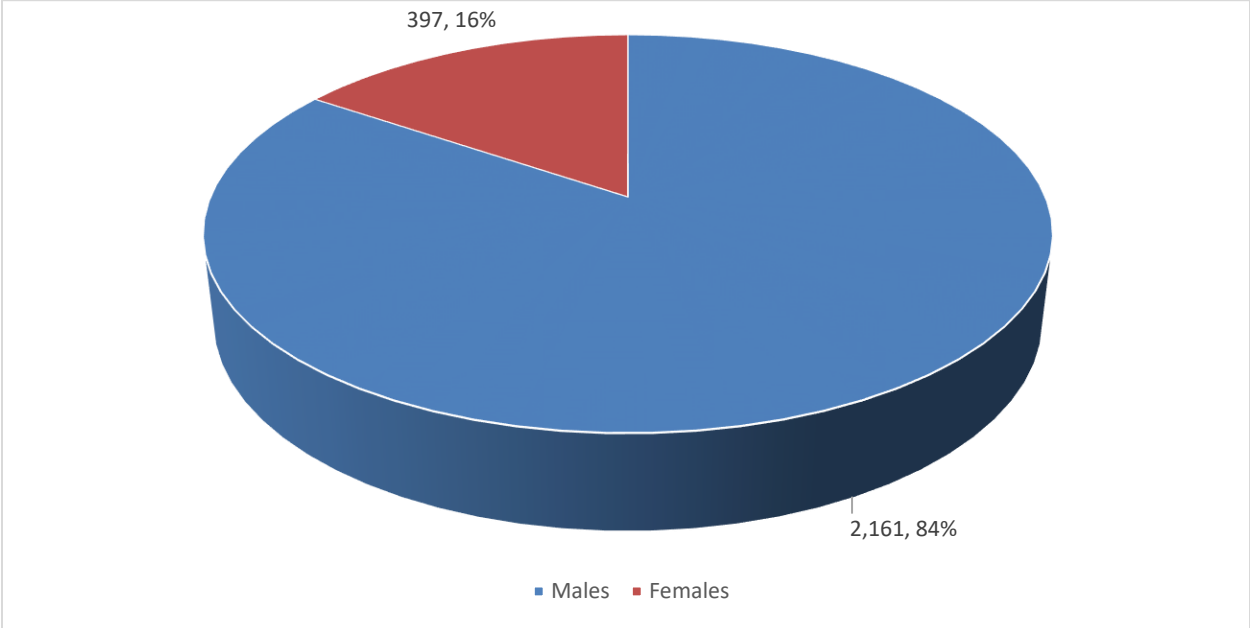


Figure 2. Alleged offenders arrested and charged for offences associated with domestic violence, by year and gender, (males & females), 2012 to 2016.

Eighty-four (84) percent of alleged offenders arrested and charged for offences associated with domestic violence in Grenada were males (Figure 2), while sixteen (16) percent of alleged offenders were females.

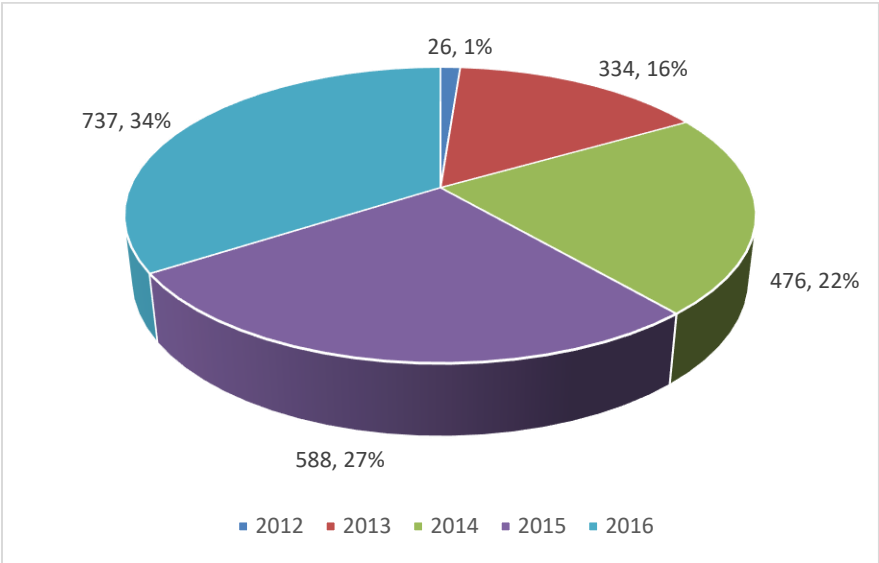


Figure 3. Alleged offenders arrested and charged for offences associated with domestic violence by year, 2012 to 2016.

Thirty-four (34) percent of all alleged offenders for domestic violence during the period 2012 to 2016, were arrested and charged in 2016 (Figure 3).

Two thousand, five hundred and fifty-eight persons (2,558) were victims of domestic violence between 2012 and 2016; this comprised seven hundred and thirty-seven (737) males and one thousand, eight hundred and twenty-one (1,821) females.

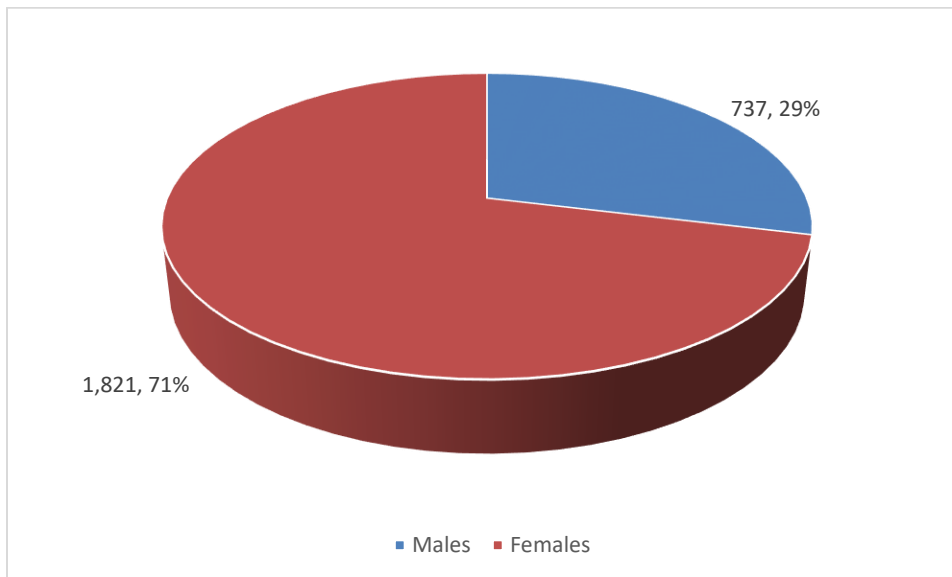


Figure 4. Victims of Domestic Violence, 2012 to 2016.

Seventy-one (71) percent of victims of domestic violence were females, while twenty-nine (29) percent were males (Figure 4).

Domestic Violence and Homicides

Incidents of homicides which are directly attributable to domestic violence, is usually preceded by a history of violence. In many cases, persons, particularly women, who were victims of

domestic homicides, had encountered domestic violence repeatedly. These homicides tend to be the end result of a history of domestic violence.

Grenada recorded ten (10) homicides in relation to domestic violence, for the period 2012 to 2016. These acts were committed by males.

Nine victims of homicides in relation to domestic violence were females, and one was a male.

Tables 3 and 4 present statistics on the number of homicides in relation to domestic violence, for the years 2012 to 2016.

Domestic Violence and Children

Children who are exposed to domestic violence can experience physical, emotional, mental, and social damages that can affect their developmental growth. These damages can be very traumatic and stressful and long-lasting.

According to data provided by the Royal Grenada Police Force, One hundred and seventeen (117) children, that is, persons under the age of eighteen years, were victims of domestic violence between 2012 and 2016. Eighty-five (85) of these victims were females, and thirty-two (32) were males.

Thirteen (13) victims were less than ten years old, while one hundred and four (104) were between ages ten to eighteen years.

Tables 5 to 7 present statistics on the number of children who were victims of domestic violence between 2012 to 2016.

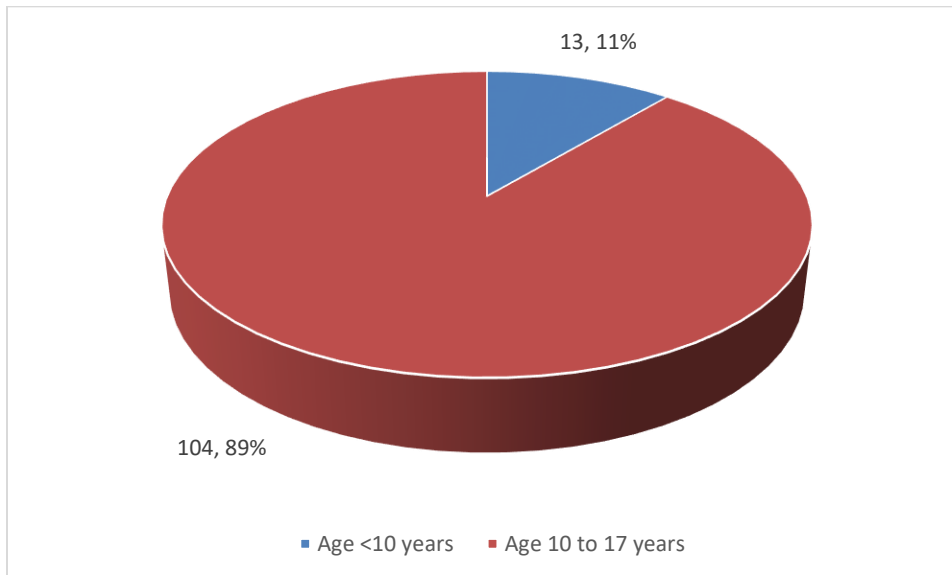


Figure 5. Children who were victims of offences in relation to domestic violence, in cases where the consumption of drugs was reported, by age range and gender (males & females), 2012 to 2016.

Eighty-nine (89) percent of all children who were victims of domestic violence during the period 2012 to 2016 were between ages ten to seventeen years; eleven (11) percent were under ten years (Figure 5).

2012 to 2016**

The Royal Grenada Police Force maintains records on incidents of domestic violence, in which the consumption of drugs was determined. This document does not seek to ascertain what role, if any, the consumption of drugs contributed to the domestic violence.

The data presented hereafter, indicate the incidents of domestic violence in which the consumption of drugs, namely alcohol and cannabis, was reported, for the period 2012 to 2016.

- i. Sixty-five (65) alleged offenders (56 males, 7 females, 2 gender not reported) were arrested and charged for commission of offences associated with domestic violence between 2012 and 2016.
- ii. Seventeen (17) victims of domestic violence were males, and forty-eight (48) were females.
- iii. Forty-two (42) percent of the persons arrested and charged were 40 years and over.
- iv. Forty-nine (49) percent of the victims were 40 years and over.
- v. Alcohol consumption was reported on ninety-six (96) percent of the males arrested and charged; cannabis consumption was four (4) percent
- vi. Alcohol consumption was reported on seventy-one (72) percent of the females arrested and charged; cannabis consumption and the use of painkillers were fourteen (14) percent each.
- vii. Cannabis consumption was reported in three cases, by the alleged offenders; two males and one female.
- viii. Seventeen (17) males who were arrested and charged were husbands, nine (9) males were boyfriends and six (6) were ex-boyfriends.
- ix. Twenty (20) of the reported incidents of domestic violence, occurred between 6:00 a.m., and 6:00 p.m.
- x. Forty-five (45) of the reported incidents occurred between 6.01 p.m., to 5:59 a.m.

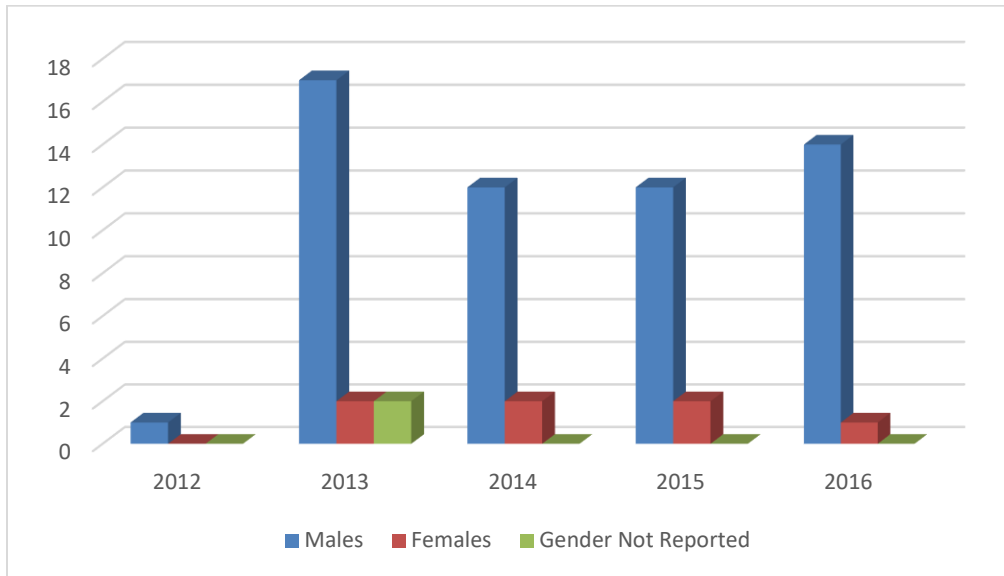


Figure 6. Alleged offenders arrested and charged for offences in relation to domestic violence, in which the consumption of drugs was reported, by age range and gender (males & females), by year, 2012 to 2016.

The highest number of alleged male offenders of domestic violence was arrested and charged in 2013 (Figure 6).

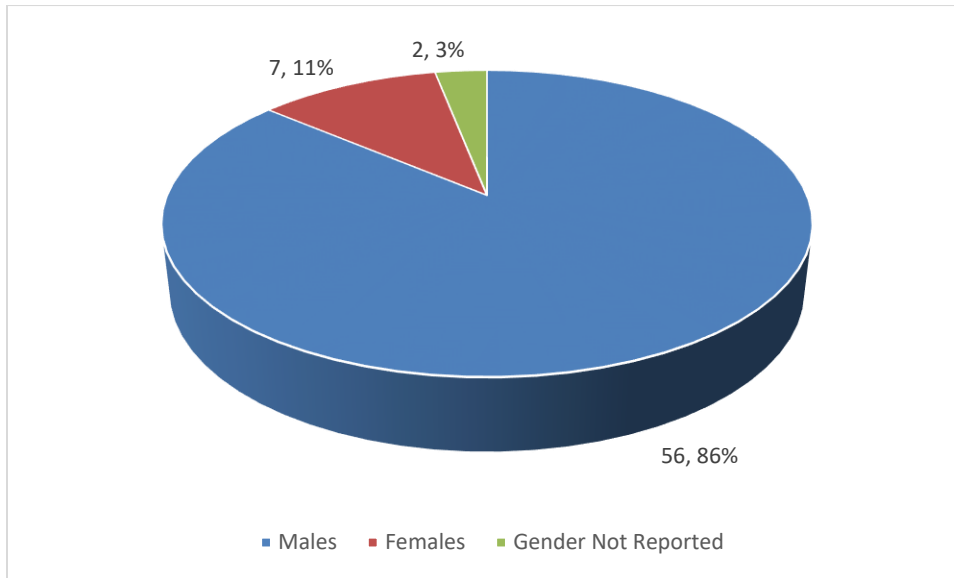


Figure 7. Alleged offenders arrested and charged for offences in relation to domestic violence, in which the consumption of drugs was reported, by age range and gender (males & females), , 2012 to 2016.

Eighty-six (86) percent of alleged offenders arrested and charged for offences associated with domestic violence between 2012 and 2016, in which the consumption of drugs was reported, were males, (Figure 7).

Seventeen (17) males and forty-eight (48) females were of victims of domestic violence, in which the consumption of drugs was reported, between 2012 and 2016.

Sixteen (16) females were victims of such violence in 2013, which represents the largest number of such females, during 2012 and 2016. (Table 9)

Husbands (17) and boyfriends (9) were recorded as the main alleged offenders of offences in relation to domestic violence, in which the consumption of drugs was reported. (Table 10)

Other relationships reported: brother, sister, son, uncle, child-father and nephew

It should be noted that these following relationships, mentioned in Table 4, comprise Intimate Partner Violence (IPV); these are: husband, wife, common law husband, common law wife, boyfriend, girlfriend, ex-boyfriend and child-father.

Twenty-seven (27), alleged offenders, which represents forty-one percent, were forty years and over; twenty-three of these persons were males.

Four (4) of the females who were arrested and charged were also forty years and over.

One (1) male was between ages fifteen to nineteen years. (Table 11)

A male victim was five months old. His father was the alleged offender.

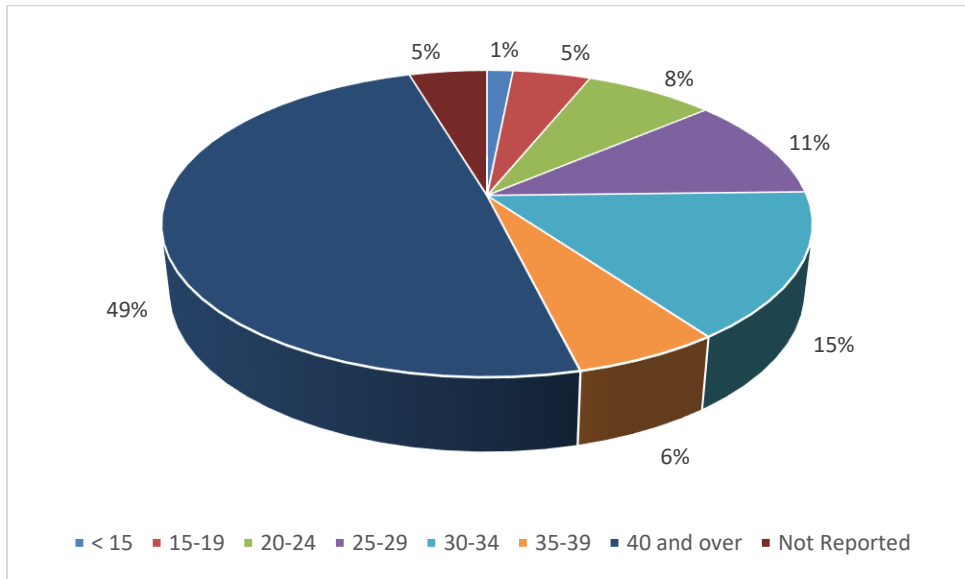


Figure 8. Victims of offences in relation to domestic violence, in which the consumption of drugs was reported, by age range), 2012 to 2016.

Forty-nine (49) percent of all victims of domestic violence between 2012 and 2016, were forty-years and over (Figure 8.)

- i. Fifty-six (56) male offenders committed offences in relation to associated domestic violence, in which the consumption of drugs were reported.
- ii. Seventy-four (74) percent of victims of domestic violence, in which the consumption of alcohol was reported, were females.
- iii. The age range forty-years and over recorded the highest number of alleged offenders, and victims.
- iv. Alcohol was the main drug reported in incidents of domestic violence.
- v. There was an increase in the number of alleged offenders and victims of domestic violence, in which the consumption of drugs each year.

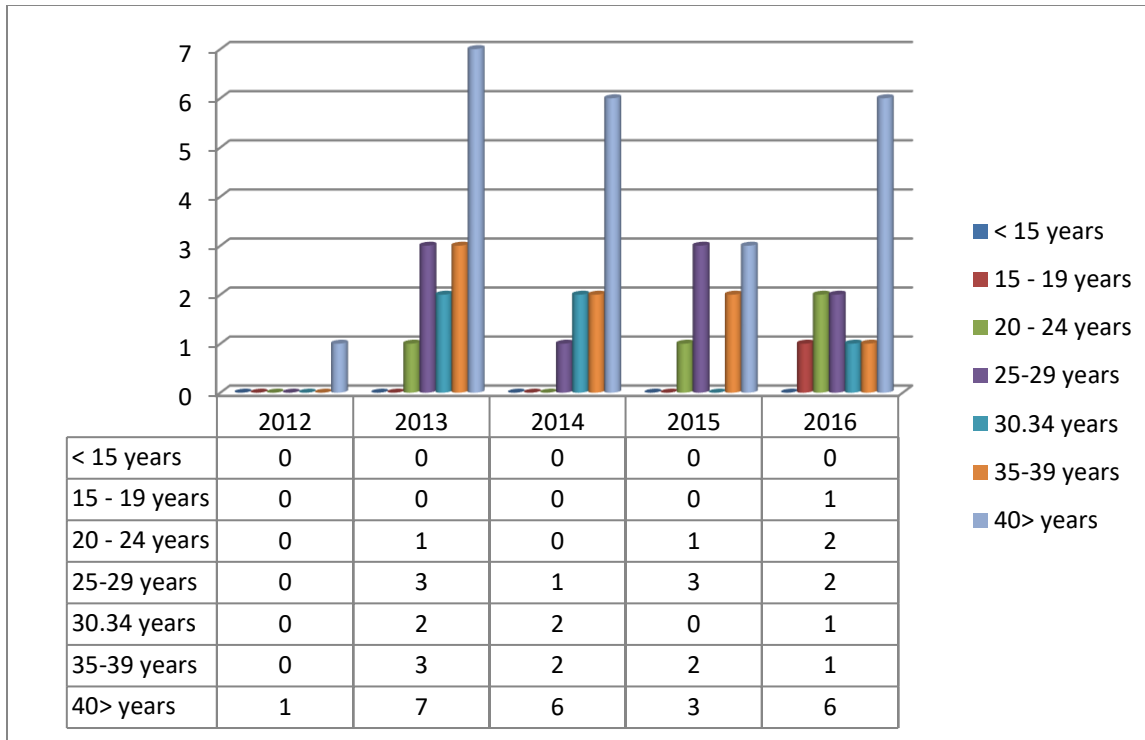


Figure 9. Alleged Offenders Arrested and Charged for Offences in Relation to Domestic Violence, in which the Consumption of Drugs was Reported, by Age Range and Gender (Males & Females), 2012 to 2016.
